Timber consists of multiple aged pine plantations, native hardwood and premerchanted pine plantation. Terrian is gently rolling with Leau Frais Creek. Tract offers opportunity for great timberland investment and diverse habitats excellent for hunting / recreation. Timber Volumes are online. 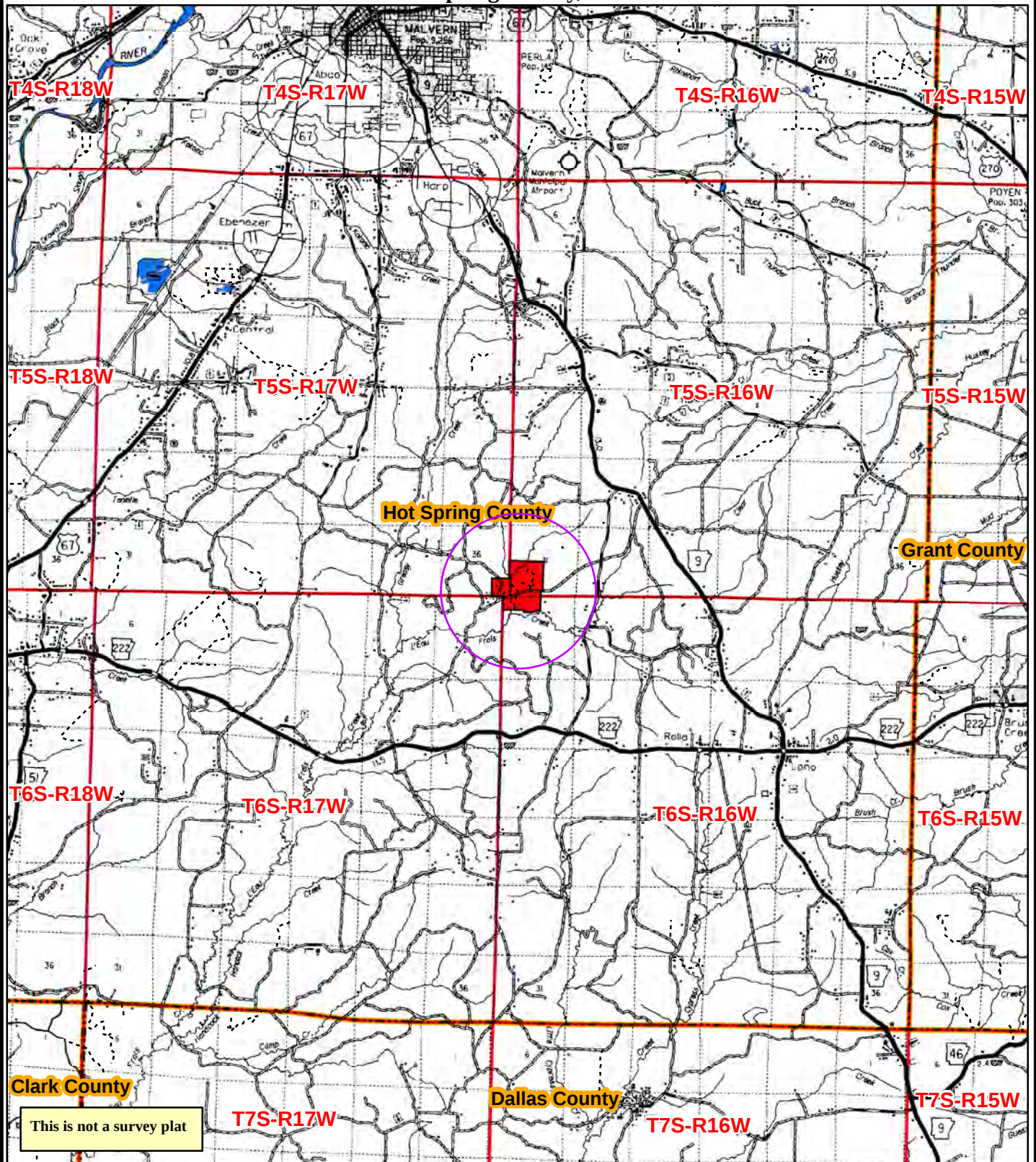

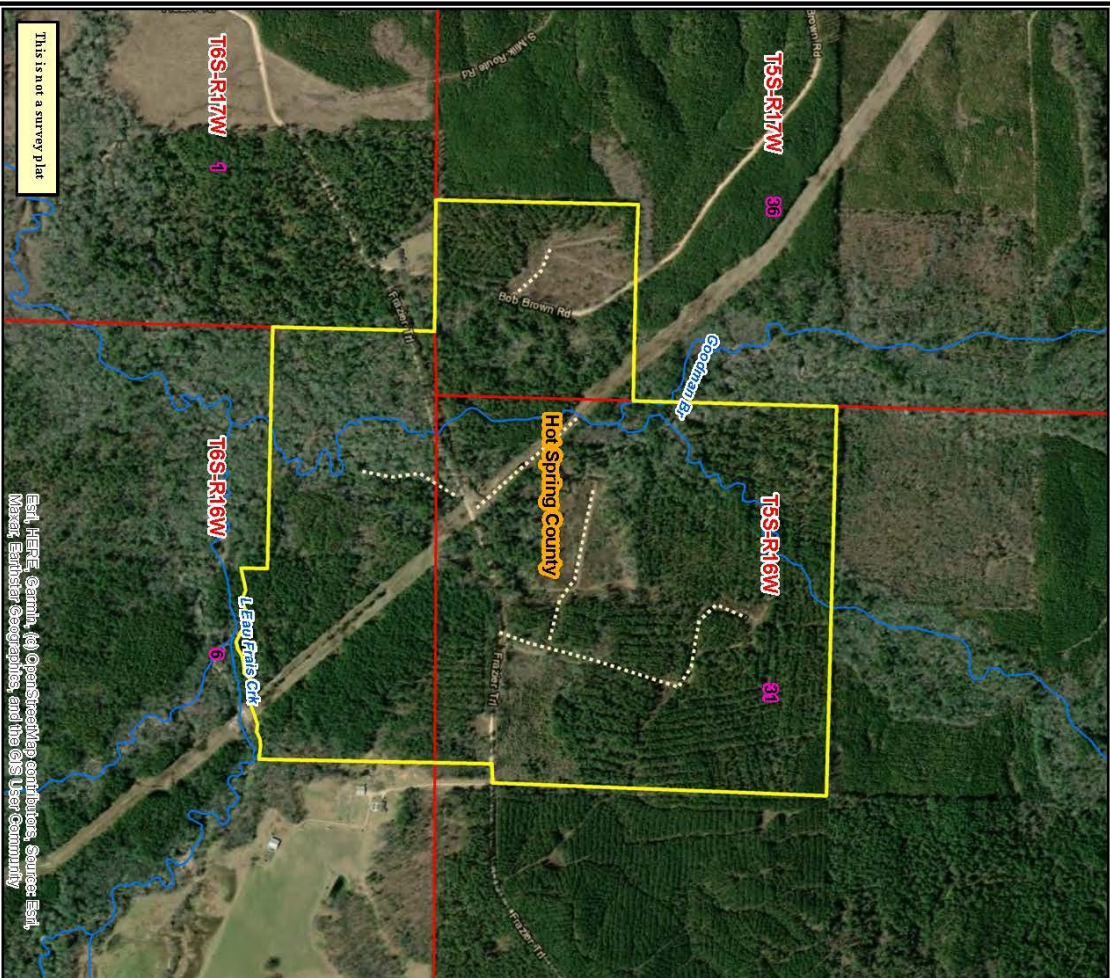

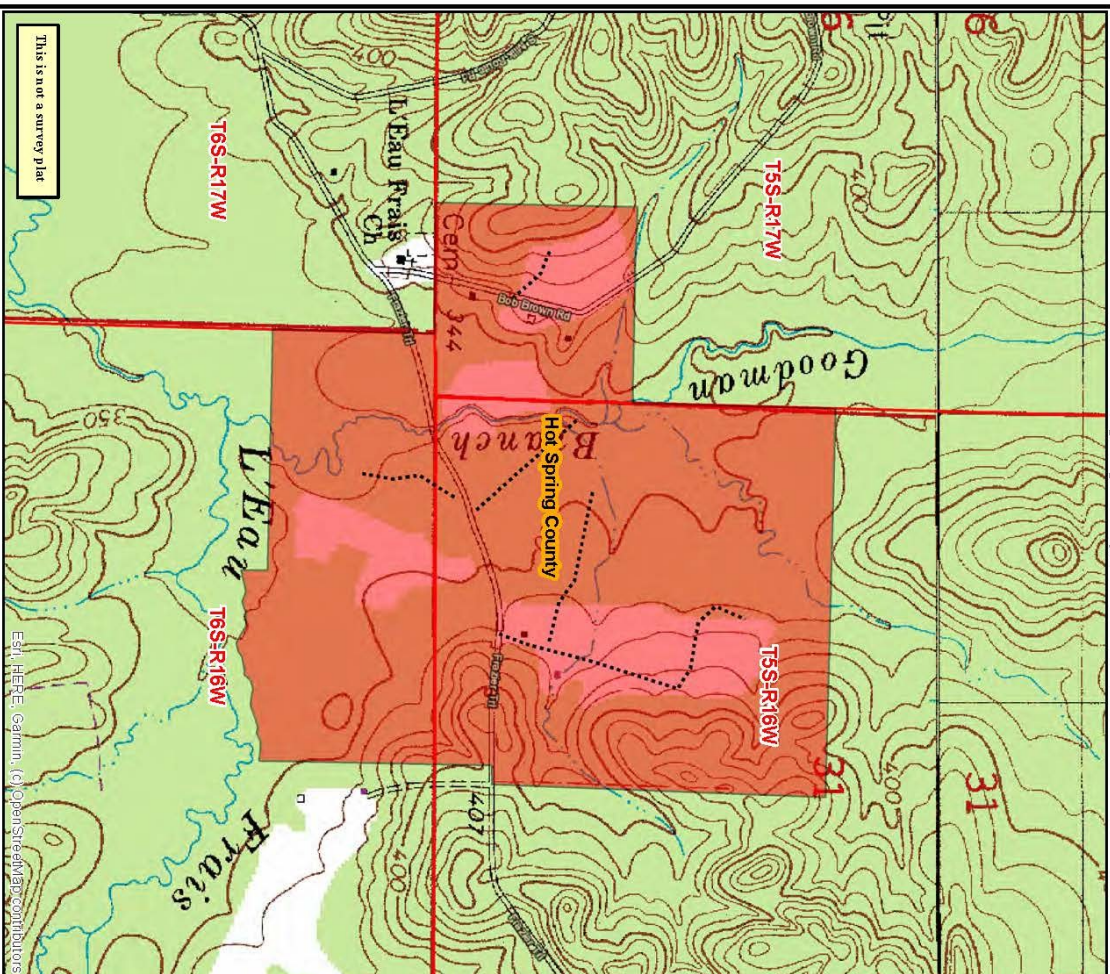
